The Tender Form

Acceptance of Tenders

Brecknockshire Agricultural Society does not bind itself to accept the lowest, or indeed, any tender. Prior to the acceptance of any tender the Secretary may contact the tenderers in order to clarify the firms tender and confirm the applicant's suitability. In addition, reference details are required on the tender form and the Society reserves the right to review and confirm the reference. Failure to provide a satisfactory facility will nullify the tenure and the Society reserves the right to retender.

Force Majeure

In the event of the show being cancelled the Society will not be liable for any of aborted costs of the tenderer.

Tender Information

As the oldest Agricultural Society Show in the United Kingdom, being established in 1755, we are keen to continue providing a high standard of amenities for the exhibitors and general public alike for which I'm sure your company will be able to provide.

Requirements:

- A temporary events licence will be required and displayed by the successful applicant.
- Supply a large/long bar with an appropriate number of staff to cope with the heavy demand. The successful contractor should ensure that during busy periods, enough staff is provided to avoid queuing as much as possible. This will also assist in maximising the contractor's profits.
- The bar and area should be kept clean and presentable. Surfaces should be smooth with no features harmful, or hazardous to customers.
- Shots etc. should not be circulated within the bar area on any promotional, or other basis especially to those customers in the younger age bracket demographic.
- Underage drinking policies and systems must be in place. Underage drinking is not accepted. The Society will accept no responsibility in the event of any breaches being identified.
- Drinks must be served in appropriate plastic glasses in accordance with current legislation.
- Drinks to include draught beer/real ale and lager, ciders, wine, shorts, pimm's and soft drinks.
- **A list of the proposed retail bar prices to be included in the tender submission including any deposit payable on glasses for the customers.**
- **Hours of Business from Midday to 11.30pm on Saturday 2nd August 2025**
- **Area to be cleared of all glasses after closing time**
- We would be grateful to receive your response by way of your **tender before 14.30pm on 12th December 2024.**
